

COVID-19 Declaration, Assumption of Risk, and Waiver of Liability Agreement

I acknowledge the contagious nature of COVID-19, and that contact with the virus may result in significant personal injury or death.

I further acknowledge that Highest Light LLC ("Highest Light") has put in place preventative measures to reduce the spread of COVID-19 during the Event, which includes this agreement.

I acknowledge that I must comply with all set procedures put in place by Highest Light during the Event to reduce the spread while in attendance.

I voluntarily seek services provided by Highest Light and acknowledge that I am increasing my risk to exposure to COVID-19, and that the risk of exposure cannot be eliminated regardless of the care taken to avoid such risks. **The risks include coming into close contact with individuals or objects that may be carrying COVID-19.**

I further acknowledge that while Highest Light has undertaken reasonable steps to lessen the risk of transmission of COVID-19 in connection with the Event, it cannot guarantee that I will not become infected.

I understand that the risk of becoming exposed to and/or infected by the COVID-19 may result from the actions, omissions, or negligence of myself and others, including Highest Light, its personnel, contractors, as well as the owners of the venue in which the Event is taking place.

I attest to the following:

1. I, or any members of my household (to the best of my knowledge), are not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, sore throat, or new loss of taste or smell.

2. I, or any members of my household (to the best of my knowledge), have not traveled internationally within the last 14 days.

3. I, or any members of my household (to the best of my knowledge), have not traveled to a highly impacted area (hot spot) within the United States of America in the last 14 days.

4. I do not believe I have been exposed to someone with a suspected and/or confirmed case of COVID-19 within the last 14 days.

5. I, or any members of my household (to the best of my knowledge), have not been diagnosed with Covid-19 and NOT YET cleared as non-contagious by state or local public health authorities.

I hereby release and agree to hold Highest Light harmless from, and waive on behalf of myself, my heirs, and any personal representatives, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of Highest Light, or that may otherwise arise in any way in connection with any services received from Highest Light.

I understand that this release discharges Highest Light from any liability or claim that I, my heirs, or any personal representatives may have against Highest Light with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Highest Light. This liability waiver and release extends to any employees and contractors of Highest Light as well as the owners, employees, and contractors of the Event venue.

I expressly agree that this Agreement is intended to be as broad and inclusive as is permitted by applicable State laws, and that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I have read, understand, and agree to this agreement including the declaration statements above.

I enter into this agreement voluntarily in consideration of the opportunity to participate in the Event.
